What is the SOS?

Standards Forum

- Improving coordination and information sharing among Federal agencies, departments and commissions
- Is a sub-cabinet level group within the National Science and Technology Council's (NSTC) Committee on Technology
- NSTC is the S&T equivalent to the National Security Council, the National Economic Council, etc.
- Highlights the importance of standards



What is the SOS?

- Comprises senior level representation from agencies
 - Ensures visibility of standards related issues at the highest levels of the government
 - Improve coordination to leverage expertise available in different agencies – IP, Innovation, Competition, Trade, International, S&T, Standards, etc.

Why another standards committee?

- Administration priorities include significant standards
 infrastructure:
 - Smart Grid
 - Electronic Health Records
 - Cloud Computing
 - Educational Technologies

- Standards are integral to President's National Innovation Strategy
- Advent of multi-disciplinary, cross-cutting technologies
- Budgetary challenges tighter Federal budgets

Why another standards committee?

- Builds on the foundation established by the National Technology Transfer Advancement Act (NTTAA) and OMB Circular A-119
- Issues not covered by NTTAA and OMB A-119 : e.g., IP and innovation
- Limitations of the Inter-agency Committee on Standards Policy (ICSP)

What will the SOS do?

- Work closely with existing Federal and inter-agency efforts that have a standards focus:
 - ICSP
 - TBT Sub-Committee of the Trade Policy Staff Committee (TPSC)
 - Other formal and ad-hoc groups
- Improve awareness of importance of standards related issues among Federal agency leaders
- Bridge the gap between technical expertise in agencies' and the leadership – some agencies are better than others

What will the SOS do?

- Initial SOS sub-groups:
 - Standards "playbook"
 - compilation of best practices and experiences of Federal agencies
 - develop metrics to measure effectiveness of agency engagement
 - coordinated by NIST and ?
 - Standards and IP
 - focus USG efforts on the issue of standards and IP
 - significant impact on ability of the U.S. interests to innovate and compete
 - coordinated by PTO and DOJ
