ANSI's Accreditation Process Based on an International Standard

- Meets the requirements of ISO/IEC 17011, *General requirements for accreditation bodies accrediting conformity assessment bodies*
 - ANSI's compliance to standard is mandatory for international recognition
 - The only personnel certification accreditation body to meet 17011 in the United States
- Involves a comprehensive paper review and an on-site visit (audit)
 - Full time staff to administer the program
 - Trained assessors approved by ANSI are engaged for the on-site visits
- An Accreditation Committee comprised of national experts (volunteers) with responsibility for:
 - Oversight, policy and procedure development
 - Determining the accreditation decision based on assessors' recommendations

ANSI/ISO/IEC 17024 – Sets the Bar for Quality

- ANSI/ISO/IEC 17024 sets the bar for quality in Personnel Certification Programs by
 - Ensuring the fairness, validity, and reliability of the examination
 - Ensure the quality of a certification program
 - Ensuring individuals pass who SHOULD pass and failing individuals who SHOULD fail
 - Ensuring a process that facilitates continued competence
 - Ensuring that due process procedures are in place to “take away” the certification for unethical or incompetent behavior
 - Ensuring a continuous quality improvement approach

Why??

- To distinguish between a certificate and a certification program
- Certification programs applying for accreditation were really “certificate” programs
- Frequency of use by the workforce is much higher
- Office of Personnel Management encouragement
- Most certificates based on “seat time”
- Few assess learning outcomes, if they do evaluate, the assessment is not aligned with learning outcomes
- Employers are concerned – “workers do not have the knowledge and skills as advertised” – cannot identify and hire qualified individuals
- “Skills gap” between education and practice
 - No integration of training/education
- No oversight of certificate programs
 - “gap” in higher education accreditation

Why are Certificate Programs the “center” of attention

- Certificates have skyrocketed more than 800% over the past
- 24% of all 23 to 65 year old workers responded that they had attended a vocational, trade or business program beyond high school
- 75% of those who had attended these schools reported having earned a certificate
- 18% of prime-age workers have obtained certificates
- 12% percent have certificates as their highest educational attainment
