 - Awareness of U.S. technical state of the art
 - Understanding potential research applications
- Risk Determination and Mitigation
 - Risk / Benefit assessment
 - Consensus balanced risk determination to mitigate risk
 - Low Tailored threat awareness training
 - Medium Disassociation from malign foreign subsidiaries (FOCI), remove conflict of interest or commitment, controlled access and monitoring
 - **High** Denial or reassignment of applicant or sub-applicant
- Program Maintenance
 - Open lines of communication
 - Routine status reports and reviews

Low Risk

No malign foreign affiliation
No Mil/Civ application
No conflict of Interest or Commitment
Fundamental research

Medium Risk

No FEOC, Potential FOCI
Previous malign foreign affiliation
Potential Mil/Civ application
Conflict of Interest or Commitment
Applied research

High Risk

Existing FEOC and FOCI
CET with Mil/Civ Application
Existing malign foreign affiliation
Conflict of Interest or Commitment
Proprietary research
Failure to Disclose or Deceptive Information
